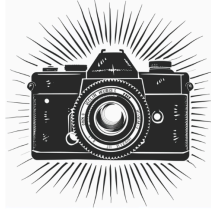


# TERMS & CONDITIONS

## HANNAH ANKETELL PHOTOGRAPHY HEADSHOT PACKAGES



### 1. BOOKING & PAYMENTS

- **Deposit:** A £50 deposit is required to confirm your booking. This ensures your time slot is reserved. Payment to be made via bank transfer or online checkout.
- **Payment:** The remaining balance is due on the day of the session, either before or immediately after the shoot. Payment to be made via bank transfer or online checkout.

### 2. CANCELLATIONS

- **Client Cancellations:**
  - Cancellations within 7 days of the shoot date will forfeit the deposit.
  - Cancellations made more than 7 days before the shoot date will result in the option to reschedule or receive a 50% deposit refund.
- **Photographer Cancellations:** If I need to cancel for any reason, you will be fully refunded, or we can reschedule for a future date at your convenience.

### 3. THE SHOOT

- **Punctuality:** Please arrive on time for your shoot. Late arrivals may result in a shortened session to accommodate other bookings.
- **Travel and Parking:** Hannah Anketell accepts no liability for any parking fines incurred for incorrect meter payment, parking in restricted areas or if your booked photoshoot runs beyond the allotted time.
- **Session Duration:** The headshot package is for a specified duration (as advertised). If you require additional time, this can be arranged, subject to availability and additional fees.
- **Outfits:** We will discuss wardrobe options before the shoot to ensure you get the best results.

### 4. IMAGE DELIVERY

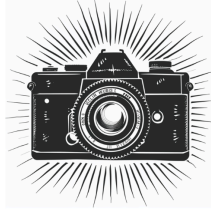
- **Turnaround Time:** Edited images will be delivered within 5 days after the session via a secure online gallery.
- **Edits:** Basic retouching is included in the package. This includes blemish removal, color correction, and light skin smoothing. More extensive edits can be requested for an additional fee.

### 5. USAGE RIGHTS

- **Client Usage:** The Buyer shall only use images in accordance with these terms. Personal, non-commercial use means the Buyer may display images on their personal computers and print for personal use. The buyer may share/display image(s) on their personal websites, social media and third party websites so long as the image is unaltered and credit is attributed
- **Photographer Usage:** I reserve the right to use the images for portfolio, website, or marketing purposes unless otherwise agreed upon.

- **Restrictions:**

The Buyer may not use images in a commercial manner to earn money, for marketing or advertising purposes, or in a trade mark, except as provided for in this Agreement.

The Buyer shall not use images in an obscene, defamatory or immoral way.

The Buyer shall not use, and shall not allow to be used the image(s) for any purposes prohibited by the laws of England and Wales.

The Buyer may not alter the images in any way.

The Buyer shall not allow others to use the image(s) and shall not use the images in a way that allows others to download, copy or redistribute the images except in accordance with these terms.

### 6. COPYRIGHT

- All images remain the property of Hannah Anketell Photography and are copyrighted by law. The client receives usage rights as outlined above but cannot sell or license the images to third parties without prior permission.

### 7. LIABILITY

- In the unlikely event of technical failures, illness, or unforeseen circumstances that prevent me from delivering the agreed-upon services, my liability is limited to a full refund or a rescheduled session.
- I am not liable for any injuries or damages that may occur during the session.
